In Vietnam, for example, state-grading of rice spirits (*lâm chảo*) is tied not only to ABV but to village-level certification, embedding traditional governance into modern regulatory architecture. Consumer advocacy groups highlight how high liability grades can disproportionately burden rural distilleries and minority-owned businesses, which lack the legal and accounting resources to navigate tiered compliance. Navajo-owned distillery in Arizona—denied wholesale distribution and subjected to audits three times annually due to its “special risk” classification—sparked national debate on whether grading systems perpetuate systemic exclusion. Supporters counter that without graduated liability, public health costs would escalate, justifying the trade-off. India’s state monopolies—dominated by Diageo-controlled United Spirits in

In contrast, South Africa’s Liquor Act of 1999 introduced a risk-based licensing system that permits microdistilleries under 1,000 liters annual production to operate under simplified grading, fostering innovation while maintaining oversight.
