He compiled it not through academic collaboration but through exhaustive reading—sifting through 18,000 books, consulting over 40 sources, and personally verifying 100,000 citations. His definition of “slave” — “a man of the African race, sold into bondage” — reveals the moral contradictions embedded in the language of his era: a document of linguistic precision shadowed by the brutal realities of empire. Johnson's work established the model of the dictionary as both a scholarly artifact and a moral statement, its authority derived not only from linguistic accuracy but from the cultural weight of its creator. The 19th century witnessed the dictionary's industrialization. The rise of publishing empires—led by figures like Henry Bradley and James Murray—transformed lexicography from solitary labor into organized industry. Murray's *Oxford English Dictionary* (OED), initiated in 1857 and completed in 1928, redefined the genre. Unlike Johnson's finite list, the OED embraced historical evolution, tracking word usage across centuries. Its method—compiling quotations from authentic texts to document first recorded appearance and semantic change—introduced a new standard of empirical rigor. Yet the OED's creation was also deeply imperial: funded by public subscription and backed by Oxford's institutional

prestige, it reflected Britain's cultural self-image as the guardian of English linguistic heritage. The dictionary became a tool of soft power, legitimizing British norms even as the empire fragmented. Globally, the English dictionary's influence diverged sharply from its British origins. In the United States, Noah Webster's *An American Dictionary of the English Language* (1828) was a deliberate act of cultural decoupling. Webster's project sought to "Americanize" spelling, grammar, and usage—replacing "colour" with "color," "centre" with "center," and "program" with "program"—not merely for phonetic ease but to assert linguistic independence from Britain. His dictionaries were imbued with nationalist purpose: language as a marker of sovereignty. This tension between British and American lexicographic traditions persists today, with each reflecting distinct cultural priorities and historical trajectories. Similarly, India's multilingual dictionary landscape reflects its postcolonial complexity—where English coexists with hundreds of regional languages, each dictionary a negotiation between tradition and modernity. The dictionary, once a definitive final word, now struggles to keep pace with language's decentralized, participatory nature. Controversies have long surrounded the editorial process. The selection of entries, definitions, and usage notes reflects editorial judgment—sometimes reflecting unconscious bias. The omission of terms tied to marginalized groups, or the framing of controversial topics (e.g., “terrorist” vs. “freedom fighter”), exposes the dictionary's role as a cultural battleground. In 2015, Merriam-Webster's decision to include “black” as a valid adjective in “Black Lives Matter” marked a shift toward recognizing social justice discourse as legitimate linguistic input. Conversely, debates over politically charged terms—“climate change,” “refugee,” “woke”—reveal how dictionaries navigate contested terrain, balancing neutrality with social relevance. Risks emerge in the digital age. Automated lexicography, powered by machine learning, threatens to depersonalize meaning-making. Algorithms trained on biased corpora risk amplifying stereotypes, while the erosion of human editorial oversight may reduce nuance.
