Conversely, diets rich in fiber, calcium, magnesium, and phytoestrogens correlate with lower incidence and slower progression. These patterns align with broader evidence that Western dietary patterns—characterized by high glycemic load, low micronutrient density, and processed food dominance—foster a pro-fibrotic environment. The biochemical mechanisms are intricate. High insulin levels, a hallmark of insulin resistance common in obesity and metabolic syndrome, stimulate fibroblast proliferation via insulin-like growth factor-1 (IGF-1) pathways. This explains why women with type 2 diabetes exhibit higher fibroid prevalence and larger tumor sizes. Similarly, diets high in saturated fats promote adipose tissue inflammation, releasing cytokines that disrupt endocrine homeostasis and accelerate fibroid growth. In contrast, plant-based diets rich in polyphenols, omega-3 fatty acids, and antioxidants exert anti-inflammatory and anti-estrogenic effects, potentially suppressing fibrogenesis. Fiber, particularly soluble fiber, binds estrogen metabolites in the gut, reducing enterohepatic recirculation and lowering circulating estrogen load—a critical factor given fibroids’ estrogen dependency. Yet this transformation demands systemic change. Public health campaigns must move beyond simplistic “eat this, avoid that” messaging to nuanced, culturally tailored guidance.
