In contrast, in East Asia, where traditional diets are already anti-inflammatory (high in fermented foods, seaweed, and fish), the model is being adapted through modern public health initiatives, such as Japan’s “Health Japan 21” strategy, which integrates anti-inflammatory principles into national wellness programs. In sub-Saharan Africa, where undernutrition and emerging metabolic diseases coexist, anti-inflammatory diets are being reinterpreted through local food sovereignty movements—promoting indigenous grains like teff and millet, and biodiversity as a buffer against inflammation. The economic footprint extends beyond food. Pharmaceutical giants now invest in nutraceuticals and anti-inflammatory biologics, with companies like Merck and Amgen funding

clinical trials on omega-3s, curcumin, and resveratrol. This convergence blurs the line between diet and drug, raising ethical questions: Should prevention be commodified? Can a diet rooted in cultural tradition be patented?
