The Velamma case offered a cautionary tale: as global supply chains grow more integrated, the failure to enforce transparency in emerging markets risks undermining long-

term investment stability. The International Monetary Fund, in a 2024 staff report, cited Velamma as a “critical case study” in the need for harmonized cross-border financial reporting standards. Controversies surrounded the episode from the outset.
