The future is collaboration: humans and machines co-designing solutions.’ Yet critics note that such narratives often obscure conflicts of interest—particularly when AI-driven discovery is patented and commercialized without transparent peer review. Regulators face unprecedented complexity. Dr. Peter Marchand, former director of the FDA’s Oncology Center of Excellence, stresses adaptive governance: ‘Regulation must evolve faster than the technology.
