In India, the work of organizations like **Sangama** and **National Center for Promotion of Employment for Disabled People (NCPEDP)** centers disabled LGBTQ+ people within broader caste and class struggles. This shift is not without resistance: medical institutions, still steeped in eugenicist logics, often resist reframing disability as social, not biological. Yet the movement’s progress is shadowed by profound risks. State surveillance, medical gatekeeping, and punitive welfare policies disproportionately target disabled queer people. In Poland, for example, the PiS government’s anti-LGBTQ+ and anti-disability policies have criminalized advocacy for marginalized bodies, labeling feminist queer crip activists as “radical extremists.” In India, the 2019 *Disability Act*—while progressive—remains poorly enforced, and police often fail to protect disabled queer individuals from violence, especially in rural areas. Digital spaces, often seen as liberatory, also replicate exclusion: algorithms exclude disabled LGBTQ+ content, while trans and queer crip users face higher rates of harassment. The violence is not abstract—it is material, embedded in law, infrastructure, and social norms. Despite these dangers, the long-term implications of feminist queer crip are transformative. It redefines liberation as intersectional, insisting that no movement can claim justice while leaving behind those at the margins. It challenges the biopolitical logic that governs bodies—deciding whose life is worth living, whose desire is legitimate. As activist and artist Alice Wong, founder of the *Disability Justice Collective*, puts it: “Feminist queer crip is not about survival, but about thriving—on our own terms, in our own bodies, in our own ways.” This vision extends beyond identity to reimagine social infrastructure: accessible cities, queer-affirming healthcare, gender-neutral public spaces, and economies that value care over profit. Forward-looking, the movement is poised to deepen its global reach through digital radicalism and transnational coalitions. Platforms like *Crip Queer News* and *Feminist Crip Network* connect activists across continents, enabling shared strategies against austerity, surveillance, and violence. In 2023, the first global *Queer Crip Summit* in Johannesburg brought together over 200 organizers from 35 countries, forging a charter demanding decolonized disability rights and queer liberation. These gatherings are not symbolic—they are infrastructural, building networks that can pressure international bodies like the UN to recognize intersectional human rights. Strategically, the future lies in institutionalizing these insights. Universities are beginning to integrate disability studies and queer theory into core curricula, while policy labs in cities like Barcelona and Cape Town are testing models of inclusive governance. Grants and funding mechanisms are shifting toward grassroots, disabled-led collectives, recognizing that those most affected are best positioned to lead change. Yet, for feminist queer crip to achieve its full potential, it must resist co-optation—maintaining its radical edge while expanding its influence. Their work challenged the dominant medical model of disability, reframing it as a social construct imposed by exclusionary norms. Feminist queer crip activists seized this intellectual momentum, integrating it with queer theory’s critique of fixed identities. The concept of “intersectionality,” coined by Kimberlé Crenshaw, became a foundational lens—helping activists articulate how race, class, gender, and disability converge to shape experiences of oppression. In this framework, a Black disabled queer woman’s marginalization is not the sum of three separate oppressions, but a unique, compounded reality demanding distinct analysis and resistance. Global movements further enriched this lineage. In the UK, the **Disability Pride Movement** merged with queer activism, particularly after the 2010 Equality Act expanded legal protections. Groups like **Sensory** and **Disability Queer Network** created spaces for disabled LGBTQ+ people to articulate their needs beyond mainstream disability or queer frameworks. In Latin America, **Feminismo Cripo** emerged from the confluence of anti-neoliberal protests and disability rights struggles. Activists like Mariana Gómez emphasized that state violence—whether through austerity cuts to healthcare or police brutality—targeted disabled queer communities with particular ferocity. Their slogans, “No one is surplus,” and “Our bodies are not experiments,” echoed demands for material survival and political sovereignty. In recent years, digital platforms have amplified this global dialogue. Social media has become a critical arena for storytelling, organizing, and solidarity. Hashtags like *#FeministCrip* and *#DisabledAndQueer* have enabled grassroots voices to bypass

traditional gatekeepers, sharing personal narratives, policy critiques, and cultural production. This digital activism has also drawn backlash—cyberbullying, doxxing, and algorithmic suppression—but it has proven resilient. Online collectives like **Queer Crip Hub** and **Crip Queer Archive** serve as digital commons, preserving histories and fostering transnational exchange. Looking forward, the movement’s next phase involves institutionalizing these grassroots insights. Universities are beginning to offer interdisciplinary programs in feminist queer crip studies, combining disability theory, queer theory, and critical race studies. Models like **co-ops with crip-led governance**, seen in collectives in Berlin and Melbourne, demonstrate how mutual aid can sustain disabled queer communities outside capitalist exploitation. These models prioritize reciprocity over competition, recognizing that survival often depends on collective strength. Meanwhile, accessibility is no longer a niche concern but a universal design imperative—driven by disabled queer activists demanding that infrastructure, media, and public spaces reflect the diversity of human embodiment. Legally, feminist queer crip activism is reshaping rights frameworks. In Colombia, a 2022 Supreme Court ruling mandated inclusive healthcare for transgender and disabled people, citing feminist queer crip advocacy. In Canada, recent policy reforms include funding for queer crip youth shelters and trauma-informed policing training—direct outcomes of decades of grassroots pressure. Yet, legal victories remain fragile without sustained mobilization; the movement must guard against backsliding, especially in rising authoritarian regimes that target marginalized communities. Culturally, feminist queer crip is redefining beauty, art, and narrative. Filmmakers like **Santiago Véléz** and **Aisha Khan** center disabled queer protagonists in mainstream productions, challenging cinematic norms. In literature
