Roman law permitted abortion under certain conditions—especially to preserve maternal health—but only within specific social hierarchies, privileging elite women and criminalizing acts deemed “unnatural.” Medieval Europe, under Christian doctrine, transformed abortion into a sin of grave moral weight, equating fetal life with spiritual personhood. The Church's influence codified a binary: life begins at conception, rendering abortion a violation of divine order. This theological framework persisted through canon law and influenced secular jurisprudence, embedding abortion's criminalization into civil codes across Christendom. Yet even then, practices persisted in secret—midsummer abortions, herbal remedies, covert terminations—revealing a persistent tension between doctrine and lived experience. The Enlightenment and rise of secular legalism began to fracture this monopoly. In 19th-

century Europe, emerging feminist movements challenged the notion that women's bodies exist solely for reproduction. Thinkers like Mary Wollstonecraft and later Simone de Beauvoir reframed bodily autonomy as a cornerstone of personhood. But legal progress was slow and violent. In the United States, the Comstock Act of 1873 criminalized not only abortion but also information about contraception and reproductive health, criminalizing both providers and seekers. This reversal is not an isolated American episode but part of a global wave of backlash against reproductive autonomy. In Poland, post-2020 near-total abortion bans—enforced through draconian penalties—reflect a resurgence of Catholic-nationalist governance weaponizing fetal personhood to consolidate morale-based authoritarianism. In Argentina, the 2020 legalization of elective abortion up to 14 weeks emerged from mass feminist mobilization, demonstrating how grassroots pressure can reverse decades of repression. In Nigeria, restrictive laws coexist with high rates of unsafe abortion, exposing the lethal consequences of criminalization. Globally, the World Health Organization estimates that 44–55 million abortions occur annually—most unsafe—with 45% of these among women in low- and middle-income countries. Restriction does not reduce demand; it criminalizes survival, fueling underground networks and mortality. The geopolitical stakes are clear: reproductive control is a tool of governance. Authoritarian regimes often weaponize fetal ideology to legitimize state oversight,

suppressing dissent by controlling women's bodies. In Venezuela, economic collapse and state-led austerity have intensified restrictions, turning abortion into a marker of political obedience. Ethically, the debate pivots on autonomy versus personhood—a tension not resolvable by dogma, but by context. The long-term implications are profound. As climate instability, economic precarity, and demographic shifts reshape societies, reproductive choice will become an even sharper axis of inequality. Nations that protect abortion access will likely see stronger social cohesion, better health outcomes, and more resilient economies.
