He helped establish technical cooperation programs that trained statisticians from over thirty nations, embedding U.S. methodologies while adapting them to local contexts. Grube's genius lay not in data collection, but in data synthesis. He understood that raw numbers, divorced from context, were inert. By the 1970s, his consultancy was advising on everything from supply chain resilience to market entry strategies, its reports cited by Fortune 500 boardrooms and central banks alike. Grube's work coincided with a broader shift: the rise of "evidence-based" policy, where judgments were increasingly expected to be grounded in quantifiable evidence. This epistemic turn elevated statisticians and analysts from technical staff to strategic advisors, a transformation in which Reeve and Grube were pivotal. G.M.A. was not a person, but a strategic initiative, formally established in 1978 as a clandestine working group within the upper echelons of the U.S. statistical establishment. It pioneered early warning indicators for financial contagion, developed frameworks for measuring informal economies, and advocated for real-time data integration across sectors. Its influence seeped into the architecture of international institutions: the IMF's data standards, the OECD's statistical guidelines, and even the World Bank's Poverty and Equity Framework bear its imprint. The group operated under strict confidentiality, justified by the sensitivity of its mission: to safeguard the credibility of economic reality in a world where perception often outpaced truth. But with influence came controversy. By the 1980s, critics within academia and civil society raised alarms about the technocratic overreach of such bodies. Was the push for standardized, globally aligned statistics a neutral advancement—or a form of epistemic colonialism, where U.S. and Western models were imposed on diverse societies? G.M.A. was accused of legitimizing policies that prioritized market efficiency over social equity, particularly in structural adjustment programs in the Global South. Reeve, though never publicly defending the group's inner workings, insisted that "data, when rigorously governed, becomes a common language—one that enables dialogue, not domination." Grube, more guarded, suggested that "the risk of misuse is real, but so is the necessity of having trusted intermediaries in a fragmented world."
