Divergent perspectives—between Western biomedical psychiatry and culturally grounded interpretations—complicated consensus. Geopolitical and Economic Undercurrents in Diagnostic Standardization

Read and Dr. Allan Horwitz, warned that this convergence risked “diagnostic creep”—where transient stress reactions or normal developmental phases became medicalized, expanding markets at the expense of marginalized populations. In contrast, low- and middle-income countries (LMICs) faced different pressures. Many lacked psychiatric infrastructure and viewed DSM-5's Western-centric criteria as culturally imperialist. Yet, the manual's emphasis on functional impairment and symptom severity offered a pragmatic framework for integrating mental health into primary care systems under WHO's Mental Health Action Plan. South Korea's high rates of mental health stigma, coupled with a cultural tendency to somatize distress, complicated diagnosis. The DSM-5's dimensional approach, emphasizing symptom clustering and severity, allowed clinicians to map overlapping anxiety and depressive symptoms, but also risked reducing her experience to a checklist. Local researchers highlighted how economic pressure, rigid social expectations, and family honor culture shaped symptom expression. Yet, the formal diagnosis opened doors to cognitive-behavioral interventions, though insurance coverage remained limited, reflecting systemic underinvestment in mental health services. ****Case III: A Brazilian**

Teenager and Borderline Personality Disorder** In 2021, a 17-year-old in São Paulo was diagnosed with borderline personality disorder (BPD) under DSM-5. BPD's diagnostic stability—based on five core criteria including emotional instability and fear of abandonment—facilitated rapid treatment planning. However, Brazilian psychiatrists expressed concern about overuse of the label, noting cultural differences in emotional expression and relational norms. The DSM's emphasis on pathology risked pathologizing normative adolescent turbulence, particularly in a context marked by high youth violence and socioeconomic inequality. Critics argued that BPD's strong genetic and neurobiological correlates, highlighted in DSM-5 research, should prompt more preventive, community-based interventions rather than individualized pharmacotherapy. Expert Perspectives: Divergent Views on Validity and Impact

Conversely, anthropologist Dr. Hadayatullah Shiddiq emphasized the cultural politics of diagnosis, warning that DSM-5's biomedical lens could marginalize non-Western healing traditions and reinforce colonial epistemologies. He pointed to ethnographic studies showing how Indigenous communities interpret distress through spiritual or communal frameworks, incompatible with DSM-5's individualistic, symptom-based model. Clinical psychologist Dr. Lisa F.
