The SEC, FCA, and ESMA have strengthened transparency rules, mandating disclosures on liquidity provision and algorithmic behavior. Yet enforcement lags behind innovation. China presents a different paradigm. With state-controlled financial institutions managing vast pools of capital, liquidity sweeps are orchestrated from behind the scenes. The People's Bank of China (PBOC) and state asset managers use centralized clearing systems to withdraw liquidity during stress, often via direct instructions rather than algorithmic routing. This top-down control
