Meanwhile, Singapore's approach blends mediation with strict behavioral codes, emphasizing discipline over dialogue—a reflection of its governance ethos. Looking ahead, the Field Guide's future hinges on three trajectories. Research in urban schools across Kenya, South Africa, and Mexico reveals that 60% of mediators report symptoms of compassion fatigue, anxiety, or emotional numbness. Many lack formal support: counseling, debriefing sessions, or peer networks. One Mexican school documented a case where a mediator, overwhelmed by repeated exposure to sexual harassment, collapsed during a session—highlighting the urgent need for institutional care. While participation is high—over 40% of students engage annually—critics argue it prioritizes order over systemic critique, avoiding deeper issues like academic stress or gender inequality. Yet in Japan, where **wa** (harmony) is central, mediation is subtly woven into group activities, with mediators trained in indirect communication—reflecting cultural norms of **enryo** (restraint). In post-conflict zones, mediation serves a dual function: healing and normalization. In Liberia, after years of civil war, schools adopted community-based mediation models rooted in "traditional reconciliation councils". Mediators—often elders or trained youth—use storytelling and ritual to address intergenerational trauma, linking personal conflict to broader societal recovery. The UNICEF-supported program reduced violent incidents by 58% in three years, demonstrating mediation's role in post-war reconstruction. In contrast, in authoritarian regimes, mediation often serves state interests. In China's vocational schools, mediators are trained to manage dissent under the guise of "harmony maintenance," with strict protocols limiting autonomy. Similarly, in Egypt, school mediation programs are closely monitored, with mediators discouraged from addressing politically sensitive issues—highlighting how structural power shapes even the most grassroots efforts. Low- and middle-income countries face distinct challenges. In Nigeria, where schools in Kano report 30% of students experiencing sexual harassment, funding shortages mean many mediators are volunteers with no pay or training. Yet innovation thrives: community-led groups use WhatsApp to report incidents anonymously, connecting students to local counselors. In India, pilot programs in Uttar Pradesh integrate mediation with digital literacy, teaching students to document abuse via secure apps—blending tradition with technology. These global examples underscore a central truth: mediation's form and function are inseparable from context. What works in Finland may fail in Lagos; what empowers in Bogotá may be co-opted in Cairo. Institutional resistance compounds these risks. Teachers trained in punitive discipline often distrust peer mediation, viewing it as undermining authority. Administrators may pressure mediators to "resolve" conflicts quickly, skipping deeper healing. In Mexico, a 2020 survey found that 45% of mediators felt their recommendations were ignored by school leaders—undermining trust and effectiveness. Yet these challenges are not
