muerto* production, reducing reliance on imported yeast while maintaining ritual authenticity. Economically, the boutique artisanal market has expanded dramatically. In France, sales of “bio-artisan” breads rose by 40% between 2020 and 2023, outpacing conventional bakery growth. In the U.S., direct-to-consumer sourdough subscriptions—many modeled on “Lighter Way” principles—grew by 180% during the pandemic, reflecting a consumer appetite for transparency, health, and craftsmanship.
