In low- and middle-income countries, mobile penetration is often concentrated among younger, male, and urban demographics, leaving rural, elderly, disabled, and low-income groups underrepresented. A 2021 study in *Nature Human Behaviour* found that globally representative samples require deliberate oversampling of rural and informal sectors, yet such efforts remain the exception rather than the norm. The result is a distorted evidence base: policy recommendations, public health interventions, and development programs often fail to account for the needs of those least counted. Expert perspectives reveal a growing awareness—and frustration—within the social science community. Sociologist Annette Lareau once noted that “representativeness is not a neutral technical choice; it is a moral and political one.” Leading demographers and political psychologists emphasize that standard sampling frames—based on census data, voter rolls, or administrative records—routinely exclude populations rendered invisible by structural exclusion: informal workers in Lagos, refugees in Jordan, indigenous communities in the Amazon. Geopolitical power imbalances further distort representation. Northern research institutions continue to dominate global data production, setting methodological standards and funding priorities. Southern scholars, despite deeper contextual knowledge, often lack access to advanced survey tools, peer review networks, and international publishing platforms. This creates a dual system: data from the Global North is treated as universal, while data from the Global South is frequently treated as supplementary or anecdotal. The UNESCO Institute for Statistics reports that less than 15% of global social science research output comes from sub-Saharan Africa and South Asia, even as these regions host over 60% of the world’s population. The long-term implications are profound. When policy is built on incomplete datasets, interventions become misaligned with reality—wasting resources,

perpetuating inequities, and eroding public trust. In education, oversampling urban students leads to curricula and assessments that disadvantage rural learners.
