Overuse of synthetic fertilizers, soil compaction from heavy machinery, and pesticide runoff—long downplayed in earlier editions—were now central concerns. The 2016 revision marked a tentative recalibration: for the first time, the Guide included sections on integrated pest management (IPM), cover cropping, and nutrient cycling, acknowledging the ecological costs of industrial monoculture.
