current law, offers broad access but limited legal protections for re-stagings. In contrast, India’s 1994 Copyright Act explicitly preserves public domain status for works older than 60 years, aligning with its constitutional commitment to cultural pluralism. Japan, blending traditional Noh and Kyōgen forms with modern one-act plays, has integrated public domain works into national education curricula, treating them as civic texts rather than relics. These variations reflect deeper philosophical divides: whether public domain works are collective heritage or individual property.
