This work did not merely describe a technique; it articulated a new epistemology. Unlike positivism, which sought universal laws through quantitative generalization, grounded theory embraced interpretive flexibility, treating theory as a dynamic, context-bound hypothesis forged in the crucible of ethnographic depth. The process demanded “constant comparative analysis,” where each case was

weighed against others, categories were refined through open and axial coding, and emerging propositions were tested against new data until saturation—a point where no further meaningful insight emerged. But grounded theory did not emerge in isolation. Its development was deeply entangled with the sociopolitical turbulence of the 1960s. The civil rights movement, anti-war protests, and rising skepticism toward institutional authority created a demand for research that could illuminate marginalized experiences with authenticity and nuance. Traditional sociological frameworks, often abstracted from the lived realities of poverty, race, and power, were increasingly seen as insufficient.
