Scholars like Walter Mignolo called for deeper inclusion of decolonial thought, urging future iterations to center Indigenous knowledge and Southern theories as foundational rather than supplementary. This dialectic—between

accessibility and depth, universality and specificity—reveals the course’s most profound impact: it catalyzed a reimagining of sociology’s role in society. It proved that the discipline could be both intellectually rigorous and widely accessible, not in spite of its complexity, but by reconfiguring how it is communicated.
