Law firms specializing in cross-border structuring now routinely advise on “risk mitigation” strategies that exploit jurisdictional gaps—using trusts in Bermuda, bearer shares in Panama, and nominee directors to obscure ultimate ownership. While legal in form, these arrangements often serve purposes indistinguishable from evasion. The result is a professional ecosystem where compliance is a performance, and legal expertise is leveraged to serve opacity.

Expert Perspectives: The Dual Narrative of Legitimacy and Illusion
