Moreover, his analysis of deglobalization trends—led by reshoring, friendshoring, and regional blocs—highlighted the erosion of universal market logic. In Southeast Asia, where Vietnam and Thailand compete for FDI, Maheshwari's "friction-weighted investment scoring" helped firms prioritize locations not just by labor cost, but by political stability, infrastructure resilience, and alignment with regional trade agreements.

The adoption of Maheshwari's models has reshaped strategic planning across sectors. In manufacturing, his dynamic friction framework enabled companies like Tata Motors to redesign supply chains with "adaptive redundancy"—maintaining backup suppliers in politically stable regions while optimizing cost elsewhere.
