It’s not a financial theory, but a behavioral intervention with measurable outcomes.’ Economists were more divided. Nobel laureate Joseph Stiglitz acknowledged its grassroots efficacy: ‘Millions have gained control over their money through these steps. But systemic change requires policy, not just personal will.’ Conversely, Dr. Raghuram Rajan, former IMF chief economist, cautioned: ‘Financial behavior is shaped by structural conditions—poverty, inequality, lack of access. Framing debt solely as a personal failure risks victim-blaming.’ Cultural critics offered sharper scrutiny. Sociologist Arlie Hochschild observed: ‘The workbook sells self-reliance as salvation, ignoring how wealth is often inherited, not earned.
