They pored over Franklin's X-ray images, particularly Photograph 51, taken in May 1952 with the assistance of Franklin's graduate student Ray Gosling. The photograph revealed a clear helical symmetry, with a distinctive X-shaped pattern indicating a helical structure with two chains. Crick's insight into base pairing—adenine with thymine, guanine with cytosine—came not from direct access to Franklin's data (which Watson viewed as improperly shared), but through indirect inference and theoretical consistency. He understood that complementary base pairing provided a mechanism for replication: each strand could serve as a template. This idea resonated with Erwin Chargaff's earlier observations of base ratios, though Watson and Crick arrived at base pairing independently. The double helix, as they realized, was not just a structural curiosity—it was a functional blueprint. The model, published in *Nature* in April 1953, included precise dimensions: a 3.4 Å repeat per turn, 10 base pairs per helical turn, and a 2 nm diameter—details validated by subsequent experiments. This breakthrough was not inevitable. It emerged from a confluence of factors: the availability of high-quality X-ray data (despite institutional rivalries), a theoretical framework linking chemistry and biology, and a cultural shift toward interdisciplinary collaboration.
