The 1720s and 1730s saw the first documented accusations: enslaved women charged with “conjuring spirits” or “harming colonizers through black magic.” These charges, recorded in ecclesiastical courts and colonial correspondence, were not merely religious panic but reflections of economic anxiety. Enslaved healers—whose knowledge of herbal medicine, midwifery, and ritual purification was indispensable—were frequently accused, revealing how spiritual authority threatened the colonial hierarchy. A 1727 report from the notary Thomas Le Moyne described an enslaved woman, Marie, “who calls spirits to heal the sick and speak to the dead”—a statement that, in context, acknowledges her role as a community healer, not a sorcerer. Yet even in accusation, a deeper reality emerges. The Spanish Inquisition’s records, though targeting perceived heresy, reveal that African spiritual practices were often indistinguishable from folk Catholicism—saints invoked alongside *orishas**, prayers to the Virgin Mary layered with ancestral invocations. This syncretism was not compromise but innovation: a way to preserve identity under surveillance. The French-Revocation of 1685, which expelled Protestants and tightened Catholic orthodoxy, further complicated matters, pushing marginalized groups—Jewish, Protestant, African—closer to shared spiritual networks as a form of mutual protection. By the mid-18th century, New Orleans’ spiritual landscape was a mosaic. Enslaved women, women of mixed heritage, and free people of color cultivated healing rituals that blended African cosmology with Catholic liturgy.
