Yet in autocratic or hybrid regimes, the

same framework becomes a tool of resistance. In Ukraine, during the 2022 invasion, journalists used subject-predicate mapping to trace Russian state-owned enterprises (subjects) orchestrating predicate acts— Disinformation campaigns, infrastructure sabotage, economic coercion. By documenting these patterns, reporters circumvented state censorship, turning individual incidents into systemic narratives that informed international sanctions and aid strategies. The predicate thus became a weapon of accountability, translating opacity into leverage. Economically, the model reshapes industry dynamics. In financial journalism, the predicate “offshore structuring” names a technique used by corporations and elites to evade taxation. Investigative teams at *Le Monde* and *Süddeutsche Zeitung* used this lens in the Pandora Papers, revealing how shell companies (subjects) enabled predicate-driven wealth concealment. The resulting exposés pressured governments to strengthen transparency laws, altering global tax practices. Similarly, in environmental reporting, identifying “carbon-intensive production” (predicate) in supply chains allows journalists to name manufacturers (subjects) complicit in climate harm—shifting public pressure and shareholder activism. The framework also

exposes asymmetries in global power. Multinational tech firms, operating across regulatory vacuums, often engage predicate acts—data harvesting, algorithmic manipulation—without clear subject accountability. Investigative reports like *The Guardian*’s 2023 probe into Meta’s content moderation (subject: platform algorithms) and predicate acts of misinformation amplification have spurred regulatory action in the EU and beyond, illustrating how precise narrative construction can compel institutional change.

In India, investigative units like **The Wire** use subject-predicate analysis to trace political funding (subjects) enabling “democratic subversion” (predicate), but
