Yet this new voice was often met with backlash, framed as “unnatural” or “disruptive.” The 1970s international women’s conferences—particularly the 1975 Mexico City World Conference on Women—marked a turning point, institutionalizing gender equality discourse. Governments and NGOs began funding programs to “empower” women, including training in communication and leadership. But these initiatives often operated through top-down models, imposing Western rhetorical frameworks on diverse cultural contexts, sometimes distorting authentic expression. Economically, the global domestic labor crisis has redefined marital dynamics.
