For instance, a 2021 survey of 1,200 dog owners in North America revealed that 43% administered lysine above the recommended range, driven by perceived benefits in chronic skin conditions and post-viral recovery, despite limited peer-reviewed support.

Geopolitical and Economic Context: The Lysine Supply Chain and Market Forces

The global lysine industry, valued at approximately \$1.2 billion in 2023 and projected to grow at 5.8% annually through 2030, is dominated by a few multinational firms: DSM (Netherlands), Evonik (Germany), and Ajinomoto (Japan). These companies source lysine primarily from fermentation-based production using engineered *Corynebacterium glutamicum* strains, a biotechnological process refined over decades. The supply chain is tightly linked to agricultural commodity markets, particularly corn and soy, which form the base of animal feed. Geopolitically, lysine production is concentrated in regions with strong biotech infrastructure and agricultural subsidies—The Netherlands, Germany, the U.S. Midwest, and Brazil. For example, the EU’s stricter authorization requirements for veterinary feed additives have limited lysine’s use in companion animals compared to the U.S., where over-the-counter availability fuels unregulated dosing. Economic incentives further complicate the picture. Yet, enforcement gaps persist, particularly in online sales, where claims like “boost immunity in dogs by 40%” circulate without scientific backing. Experts also critique the commercialization of lysine as a case study in “nutritional populism”—where scientific complexity is simplified for market appeal. The rise of direct-to-consumer dosing calculators, often algorithm-driven and opaque, further erodes professional oversight. As Dr. Amara N’Dour, a bioethicist at the University of Cape Town, notes: “We’re witnessing a democratization of dosing that empowers users but undermines expert gatekeeping. The challenge is to balance access with accountability.”
