This exclusivity exacerbates governance challenges, as public policy is often articulated in a register inaccessible to large segments of the population. Efforts to incorporate

indigenous languages—such as South Africa’s constitutionally recognized eleven official languages—aim to bridge this gap, but implementation remains uneven. These comparative cases underscore a fundamental truth: language is not neutral, but a cultural artifact shaped by history, power, and identity.
