The Soviet PPSH-41, chambered in 7.62×39mm, introduced a new standard for submachine gun performance. The Mosin-Nagant’s evolution from a 19th-century rifle to a war-torn instrument of mass production exemplifies this resilience. Economists analyzing Soviet wartime economics noted that while output was immense, productivity per worker lagged behind Western counterparts due to logistical fragmentation and maintenance neglect.
