The geopolitical context was equally pivotal. The early 2010s saw the Global South asserting greater influence in international institutions, challenging Eurocentric historiography. Decolonization movements, reparations debates, and the rise of digital archives democratized access to historical materials, pressuring textbooks to diversify content. *History Alive* responded by integrating global

This instrumentalization risks reducing complex historical processes to episodic moral lessons, undermining the nuanced, dialectical thinking the series initially championed.

Controversies: The Politics of Memory in the Classroom
