This top-down standardization, while promoting baseline competencies, risks marginalizing context-specific expertise. In settings where traditional birth attendants or community midwives operate outside formal systems, MCQs fail to capture nuanced, culturally grounded knowledge. The tension between universal metrics and local relevance remains unresolved, exposing a fundamental flaw in technocratic approaches to global health education.
