Trade policies and intellectual property regimes further complicate the landscape. Patent protections shield high-end innovations but inflate costs, limiting access in low-income settings. The TRIPS Agreement under WTO frameworks attempts to balance innovation and access, yet enforcement varies. Meanwhile, China’s rise as a generative manufacturing center challenges Western dominance, enabling rapid prototyping and cost reduction—but raising concerns about quality control and ethical sourcing. The geopolitical dimension extends to humanitarian intervention. In refugee crises—Ukraine, Syria, Gaza—prosthetic services become vital yet precarious. International NGOs deploy mobile clinics and tele-rehabilitation, but political instability, sanctions, and infrastructure collapse often hinder sustained care. The 2023 collapse of prosthetic services in Gaza, following repeated infrastructure damage, underscored how conflict disrupts not just lives but engineered systems of restoration. Economically, the prosthetics industry is a microcosm of broader healthcare trends. It is capital-intensive, requiring significant R&D investment, yet increasingly digitized and data-driven. Wearable sensors, cloud-based analytics, and AI-driven customization are transforming traditional manufacturing into adaptive, personalized care. This shift favors nations with strong digital infrastructure—such as South Korea and Singapore—while challenging low-tech environments. Yet economic viability remains uneven. In high-income countries, insurance coverage and regulatory frameworks support sustainable models. In lower-income settings, reliance on foreign aid and volunteer networks creates fragility. The World Bank estimates that every \$1 invested in rehabilitation yields \$4 in economic returns through restored workforce participation—yet funding gaps persist, with less than 10% of global health aid
