Yet beneath this order lies a dense network of implicit assumptions about trust, accountability, and power. It codified roles for providers as de facto extensions of state capacity, embedding legal obligations that blurred the line between corporate governance and public administration. For instance, Section 4.7 mandates real-time logging of access requests, justified as “transparency for accountability,” but in practice, enables extensive surveillance under national security pretexts.

Geopolitical and Economic Context: A Digital Cold War in Infrastructure
