Critics accused platforms of suppressing conservative voices, while defenders cited efforts to curb extremist content. This tension underscored a broader crisis: the privatization of public discourse and the erosion of neutral digital spaces. The Freedom Assembly thus catalyzed debates over platform governance, transparency, and the future of democratic communication.
