damages; Smith calculated that without adaptation, such events could recur every 18 months by 2050, with cumulative costs exceeding \$1 trillion. In China, massive coastal development was driven by centralized planning and massive public investment, yet local authorities often bypassed environmental safeguards to meet growth targets. Smith's 2021 comparative study, **Coastal Governance in Crisis**, contrasted these models, arguing that resilience requires not just engineering, but institutional flexibility and inclusive decision-making. Smith's analysis extended to digital and data infrastructure. Undersea fiber-optic cables, critical for global internet connectivity, traverse vulnerable coastal zones. A 2019 investigation revealed that 40% of these cables passed through areas with high erosion risk, threatening global communications. Smith's 2017 report, "The Insurance Paradox," showed that premiums in high-risk zones had risen 300% over a decade, while coverage dropped by 40%, leaving communities underinsured and governments to absorb the fallout. His work also challenged the narrative of "green growth" in coastal zones. Renewable energy projects—offshore wind farms, tidal power stations—were often sited in ecologically sensitive areas, with inadequate consultation.
