The Nixon-Kissinger breakthrough thus established a framework of asymmetric interdependence: each leveraged the other's strategic vulnerabilities to advance mutual interests. This architecture, though tested by subsequent crises, endured as a model of great power maneuvering in a multipolarizing world.

Industrial Transformation: From Isolation to Global Integration

Before 1972, China's economy was largely closed, with limited foreign investment and minimal integration into global supply chains.
