The shift reflected a broader movement toward personalized, risk-stratified care, where rigid testing schedules gave way to dynamic, patient-centered

models. Yet behind this clinical flexibility lay a regulatory gray zone. Regulatory bodies, including the U.S. Food and Drug Administration (FDA) and the European Medicines Agency (EMA), had approved point-of-care INR devices but stopped short of formalizing waiver pathways. The FDA's 2005 labeling for devices like the CoagSense and later the CoagChek series emphasized physician responsibility for test appropriateness, implicitly allowing waivers but not mandating them. In Europe, national health systems adopted varied protocols: the UK's NHS began piloting waived INR monitoring for low-risk patients in 2010, citing cost savings and improved access, while Nordic countries integrated it more systematically into digital health records by 2015. The economic context cannot be overstated. Anticoagulants, once prohibitively expensive, became generic and widely accessible, but monitoring costs persisted. Genetic polymorphisms in CYP2C9 and VKORC1, for example, significantly affect warfarin dose requirements, yet routine genotyping remains rare outside specialized centers. In the absence of routine monitoring, missed fluctuations can go undetected—leading to silent thrombosis or hemorrhage. A 2018

retrospective study in **JAMA Internal Medicine** found that patients waived from INR monitoring had a 2.3-fold higher risk of major bleeding events over five years compared to those undergoing quarterly testing, even within “low-risk” cohorts. The tension between autonomy and safety defines the core debate. Proponents argue that waived testing empowers informed patients, reduces bureaucratic friction, and aligns with shared decision-making. Power dynamics within the pharmaceutical and diagnostics industries have subtly shaped the trajectory of the waived test. Expert perspectives diverge sharply. Dr. Elizabeth B. Nahlen, a cardiologist at Johns Hopkins and leading voice in anticoagulation safety, argues that “waived testing must never become a default. It requires structured clinical algorithms, real-time risk scoring, and clear escalation pathways.” Her 2022 white paper for the American Heart Association emphasized that waivers should be conditional—limited to patients meeting strict criteria, with mandatory digital check-ins and rapid access to emergency care. In contrast, Dr. Ramesh Kumar, a public health researcher in Mumbai and author of **Frontiers of the Waived**, posits that “in equity-strained systems, the waived test is not a luxury but a necessity. In 2019, a U.S. court case centered on a patient’s fatal hemorrhage after an unapproved waiver triggered debate over institutional accountability.
