Pakistan's hybrid model, China's system lacks judicial independence, but benefits from centralized enforcement. In the European Union, post-2008 reforms emphasized transparency and competition, with the Single Supervisory Mechanism (SSM) and Deposit Guarantee Schemes (DGS) aiming to depoliticize oversight. Yet, even here, the rise of sovereign-backed lenders—such as Germany's KfW—blurs the line between public and private, echoing jaiib dynamics without formal nationalization.
