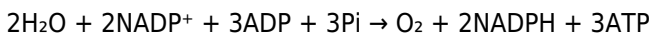

At the molecular level, photosynthesis is a marvel of biochemical engineering. The two primary stages—light-dependent reactions and the Calvin cycle—operate in a tightly coordinated sequence. In the thylakoid membranes of chloroplasts, photosystems II and I capture photons, exciting electrons that drive ATP synthesis via photophosphorylation. Water is split in Photosystem II, releasing oxygen, protons, and electrons; this process, though seemingly simple, represents a radical transformation of inorganic molecules into life-sustaining energy carriers. The Calvin cycle, occurring in the stroma, uses ATP and NADPH to fix CO_2 into glyceraldehyde-3-phosphate (G3P), the precursor to glucose.
