But *Jackpot* refracted these through a contemporary lens—blending *kōla* cadences with stand-up comedy, digital projections of war-time photographs, and a mobile sound system powered by solar panels. The play was structured in four acts, each mapping a phase of crisis and resilience, not chronologically, but psychologically: the first, *The Jackpot of Loss*; the second, *The Currency of Silence*; the third, *The Stage of Shadows*; the fourth, *The Jackpot of Memory*. The geopolitical context of its birth cannot be overstated. Sri Lanka’s civil war (1983–2009) had not only displaced millions but fractured communal trust, turning shared cultural spaces into battlegrounds of competing narratives.
