In a 2012 *Bioethics* journal article, Savulescu warned that de-extinction could divert resources from conserving endangered species: “We risk becoming genetic tourists, chasing spectacles while biodiversity collapses.” His argument gained urgency as high-profile de-extinction projects—such as Colossal Biosciences’ effort to bring back the woolly mammoth—drew millions in private funding. Meanwhile, legal scholars debated jurisdiction: Who owns ancient DNA? Could a reconstructed species be patented? The U.S. Patent and Trademark Office rejected early attempts to patent mammoth-derived genes, citing lack of novelty, but international treaties remained fragmented. The Nagoya Protocol on Access and Benefit-Sharing (2014) sought to regulate genetic resource use, yet enforcement lagged, especially in regions rich in paleontological heritage like Siberia, Patagonia, and South Africa.

Controversies and Risks: From Lab Containment to Public Backlash

The path from hypothesis to prototype was fraught with technical failure and public scrutiny. Early attempts to extract viable DNA from 10,000-year-old fossils repeatedly failed—contamination, fragmentation, and chemical degradation proved insurmountable. A 1999 study in *Nature* documented the

complete failure to sequence a functional mammoth genome from permafrost samples older than 1.2 million years, underscoring the limits of preservation. In 2005, a leaked memo from a private biotech firm revealed plans to use extinct species for “biological insurance” systems—hiding de-extinct organisms in remote reserves as insurance against future extinctions. Conservation groups like Greenpeace condemned it as “scientific colonialism,” echoing fears that de-extinction would justify ongoing habitat destruction under the false promise of future fixes. Risk assessments by the National Academy of Sciences (NAS) in 2012 concluded that while genome editing was advancing, full de-extinction remained speculative.
