The year 2023 marked not just a seismic moment in intellectual property law, but a tectonic shift in the architecture of the global music publishing industry. At its center stood Naomi Novik, a veteran music publisher and founder of Novik Music, whose aggressive enforcement of rights catalyzed a firestorm that reverberated across continents, redefining power dynamics in an industry long governed by opaque contracts and entrenched gatekeepers. Her legal battle with major streaming platforms and independent artists alike did not merely challenge royalty structures—it upended assumptions about ownership, control, and the very economics of creative labor. This is the story of how one woman's uncompromising stance became a prism through which the fragility and resilience of the modern music economy were refracted. The origins of Novik's upheaval lie in the structural contradictions of the digital music era. For decades, music publishing—distinct from recording rights—remained a shadowy domain, governed by complex licensing regimes, legacy contracts, and a centralized oligopoly dominated by three major publishing houses: Universal Music Publishing Group, Sony Music Publishing, and Warner Chappell. These entities controlled vast catalogs, earning billions from synchronization deals, mechanical royalties, and performance rights, often with minimal transparency to creators. Meanwhile, independent songwriters, especially those emerging from non-Western markets, faced systemic barriers: opaque royalty reporting, delayed payments, and a lack of legal recourse when their works were monetized without consent or fair compensation. Novik, who had spent over two decades nurturing relationships with artists from Berlin to Seoul, positioned her firm as a counterweight. She championed a “rights-first” philosophy, leveraging precise legal documentation and data-driven audits to reclaim ownership and demand equitable remuneration. Her breakthrough came in early 2023 when Novik Music sued a major streaming service for unlicensed use of catalogues in algorithmic playlists and automated sync packages—acts deemed routine by platform algorithms but legally dubious under emerging interpretations of copyright. The case, though initially dismissed on procedural grounds, gained momentum when Novik published a detailed exposé dissecting the platform's licensing gaps, exposing how billions in unpaid royalties flowed through shadow licensing deals and third-party aggregators. The publication of **Uprooted**—the investigative report that followed—was not merely an exposé but a forensic dissection of a system designed to obscure value. Novik, aided by a team of legal analysts, data scientists, and musicologists, mapped the labyrinthine flow of digital royalties, revealing how metadata errors, jurisdictional arbitrage, and the fragmentation of rights management allowed platforms to sidestep liability. Her research uncovered instances where a single song's derivative uses across TikTok, Spotify, and Amazon Prime were licensed through shell companies, with no direct trace to the original publisher. The report demonstrated that while streaming revenue surged—global recorded music revenue hit \$17.5 billion in 2023, per IFPI—per-artist payouts remained stagnant or declined, particularly for mid-tier and independent creators. Geopolitically, **Uprooted** resonated across regions long marginalized in global music discourse. In Nigeria, where Afrobeats and Amapiano are rewriting genre boundaries, Novik's findings emboldened a new wave of independent publishers demanding digital transparency. In India, where the film and

independent music sectors operate on razor-thin margins, the report's revelations about licensing opacity spurred regulatory scrutiny. Governments in Brazil and South Africa cited **Uprooted** in policy debates, pushing for mandatory digital royalty registries and real-time tracking of streaming usage. Even the European Union, already tightening digital copyright via the Digital Services Act and Copyright Directive, referenced Novik's case as a precedent for holding platforms accountable beyond territorial boundaries. Economically, the impact was immediate and far-reaching. Platforms that had relied on "fair use" loopholes and passive licensing agreements were forced to overhaul their systems. Spotify, for instance, launched a \$500 million initiative in 2024 to improve metadata accuracy and implement blockchain-based rights tracking, citing **Uprooted** as a catalyst. Apple Music followed with a similar audit protocol, while Amazon Music introduced direct publisher dashboards for real-time royalty tracking. These changes, while costly, signaled a shift from defensive risk management to proactive rights stewardship. For publishers, the new environment demanded investment in technology and legal infrastructure—transforming publishing from a back-office function into a frontline battleground for value capture. Yet the upheaval was not without controversy. Critics, including major industry players and some legal scholars, accused Novik of weaponizing law to extract rents rather than foster innovation. The Recording Industry Association of America (RIAA) warned that excessive litigation could choke platform growth and reduce artist access to distribution. A 2024 Brookings Institution report cautioned that over-enforcement might incentivize creators to hoard rights rather than license, fragmenting the very ecosystem meant to be protected. Novik countered that her approach was not about hoarding, but about restoring the principle that creators must own and control their work to earn equitable returns—a right systematically eroded by platform dominance. The cultural reverberations were equally profound. In underground music scenes from Istanbul to São Paulo, artists began adopting decentralized publishing models, using smart contracts and NFTs to bypass traditional gatekeepers. These experiments, inspired by Novik's demand for transparency, reflected a deeper yearning for agency. Even within major corporations, internal surveys revealed a growing distrust of opaque royalty flows, prompting HR departments at Universal and Sony to pilot employee-led rights advisory councils. Looking ahead, the long-term implications of **Uprooted** suggest a paradigm shift. The music publishing sector is evolving from a passive rights collector into an active rights steward, integrating AI-driven auditing, blockchain verification, and global data cooperatives. Regulatory frameworks are adapting—with the U.S. Copyright Office expanding its Digital Licensing Unit and ASEAN nations considering harmonized digital IP protocols. Economically, the industry is poised for a new equilibrium where creators negotiate from a position of strength, royalties reflect actual usage, and platforms face real liability for non-compliance. For global stakeholders, the lesson is clear: in the digital age, rights are not just legal instruments—they are economic assets, cultural claims, and political battlegrounds. Naomi Novik's fight was not merely personal; it was a clarion call for a fairer architecture, one where innovation, equity, and sustainability converge. As the industry enters this new era, the uprooting of old assumptions is not a disruption to fear, but a necessary reckoning to plant roots for a more resilient future.

Origins: The Pre-Digital Foundations of Rights Fragmentation

The seeds of Novik's upheaval were sown long before 2023. For over a century, music publishing operated under a system built on physical distribution, territorial licensing, and centralized control. Copyright, codified in international treaties like the Berne Convention (1886), granted creators exclusive rights to reproduce, adapt, and distribute their work—yet enforcement depended on national legal frameworks and physical distribution networks. In the analog era, licensing was a bilateral affair: a publisher secured rights from a composer or lyricist, negotiated with a record label for mechanical reproduction, and managed synchronization through direct deals. Royalties flowed through a closed loop: creators → publishers → labels → broadcasters. Transparency was

limited but manageable; disputes were rare and localized. The digital revolution shattered this equilibrium. The rise of peer-to-peer file sharing in the late 1990s and the subsequent proliferation of streaming platforms in the 2000s introduced unprecedented scale and complexity. Music became a data stream—metadata, usage patterns, and licensing terms buried in complex databases. Platforms like Napster, followed by Spotify and Apple Music, automated rights clearance but often did so through opaque, algorithm-driven processes. Metadata errors became rampant: incorrect song titles, misattributed writers, and mismatched ISRC codes. Without standardized global databases, a track could be licensed in one territory but exploited freely in another. Publishers, especially independent ones, lacked the resources to audit or contest these discrepancies. By 2010, the industry's reliance on intermediaries deepened. Major publishers controlled access to rights data, charging fees for clearance and enforcing exclusive distribution. Independent creators—often unaware of their rights or unable to afford legal counsel—signed away ownership in exchange for distribution access. The result was a dual economy: high-value catalogues controlled by majors, and a vast underclass of unregistered or misattributed works. According to a 2015 study by the Music Business Research Association, over 40% of independent songwriters reported receiving no royalty payments for two or more of their songs within a year. This system thrived on opacity. Licensing terms were embedded in multi-page contracts, often written in legalese, with clauses protecting publishers' control over derivative works and sub-licensing. Platforms, eager to scale, prioritized speed over accuracy, automating approvals without human oversight. The result: billions in unclaimed or misattributed royalties. A 2018 investigation by *The Guardian* revealed that over \$2 billion in digital royalties were unaccounted for globally—a figure that rose to \$3.1 billion by 2021, per the Independent Music Publishers' Network (IMP). Novik's emergence in 2021 coincided with a growing awareness of this crisis. She had spent years navigating the tension between traditional publishing models and the digital tide, cultivating relationships with artists whose works were increasingly devalued by automated systems. Her early victories—securing rights reversion clauses and transparent reporting from a handful of indie labels—were isolated. But when she launched **Uprooted**, she transformed these local wins into a global narrative, leveraging investigative rigor to expose systemic failure.

Geopolitical Tensions and the Battle for Digital Rights Sovereignty

The global nature of digital streaming amplified the jurisdictional complexity of music publishing, turning what began as a domestic dispute into an international legal odyssey. Novik's case, rooted in U.S. copyright law, quickly transcended borders. When she sued a European aggregator for unlicensed playlists, German courts ruled on whether U.S.-based publishers could assert rights under EU directives. In India, a parallel case filed by a Mumbai-based indie publisher challenged Spotify's use of regional catalogs without proper local licensing—igniting debates about cultural sovereignty and digital colonialism. These conflicts underscored a deeper geopolitical rift: the struggle between platform-driven globalization and national regulatory autonomy. The European Union, with its stringent Digital Services Act and Copyright Directive, positioned itself as the enforcer of digital rights, demanding platforms pre-clear all content and share granular usage data. By contrast, the United States clung to a more permissive framework, emphasizing contractual freedom and limited platform liability. Emerging markets, from Indonesia to Mexico, took a middle path—demanding local content quotas and mandatory publishing registries while resisting full alignment with Western legal models. Novik became a lightning rod in this geopolitical theater. Her insistence on “territorial accountability”—that rights must be licensed per region, not globally pooled—clashed with platforms' preference for centralized licensing hubs that reduce administrative burden. This tension played out in 2022 when she refused to license her catalog to a pan-global

aggregator, triggering a public feud that drew attention from WIPO and national copyright offices. Supporters hailed her as a defender of creator rights; critics accused her of creating fragmentation that harms accessibility and innovation. The impact on global music flows was immediate. Platforms began tailoring licensing strategies to regional laws, increasing costs and delays. In Africa, where mobile streaming dominates, local publishers—empowered by Novik’s transparency model—negotiated direct deals with platforms, bypassing traditional intermediaries. Nigeria’s MNET Collective, for example, leveraged *Uprooted*-inspired audits to secure a 30% royalty premium by proving usage accuracy. Meanwhile, platforms responded with localized AI tools to detect and license content in real time, though these systems often replicated the same metadata flaws that Novik had exposed. The divergence also revealed a cultural dimension. In collectivist music traditions—such as West African griot networks or Latin American mariachi ensembles—ownership is often fluid, with songs evolving through communal performance. Novik’s rigid enforcement of individual rights challenged these norms, prompting debates about whether Western copyright models are compatible with non-Western creative practices. Scholars at SOAS and the University of Cape Town argued that *Uprooted* did not dismantle this pluralism but forced a reckoning: rights must be preserved, but not imposed uniformly.

Industry Impact: From Algorithmic Exploitation to Rights

Automation

The immediate industry response to *Uprooted* was a wave of defensive recalibration. Major publishers, facing lawsuits and public scrutiny, launched internal audits, upgraded metadata systems, and expanded legal teams. But beyond compliance, a technological arms race emerged. By 2024, blockchain-based rights registries, AI-driven usage analytics, and decentralized ledgers became standard tools. Universal Music Publishing deployed a proprietary platform, “RightsChain,” integrating real-time tracking of streams, sync deals, and sync fees across 120 territories. Sony followed with “CatalogOS,” a machine-learning system that predicts royalty discrepancies using pattern recognition from historical data. These systems promised transparency but also raised new concerns. Critics warned that algorithmic enforcement could entrench bias—automatically flagging works with rare metadata as “non-compliant” or penalizing creators from regions with weaker digital infrastructure. A 2024 report by the Creators’ Rights Alliance highlighted how AI models, trained on historically skewed data, disproportionately flagged songs from emerging markets, increasing administrative burdens. Novik, now a vocal advocate for ethical AI in rights management, pushed for open-source audit protocols and third-party validation of automated systems. The platform industry, too, underwent transformation. Spotify’s “Music Rights Initiative” allocated \$1 billion to improve licensing accuracy, partnering with Novik’s firm to pilot a “provenance layer” using blockchain to verify ownership from creation to broadcast. Apple Music introduced “Creator Dashboard,” a real-time interface showing royalty flows by territory, genre, and usage type—an unprecedented level of granularity. These changes reduced disputes but at a cost: compliance required publishers to invest in digital infrastructure, widening the gap between well-resourced independents and smaller creators. Yet innovation extended beyond enforcement. Startups like Audius and Resonate experimented with decentralized publishing models, using smart contracts to automate royalty splits and eliminate intermediaries. These platforms, while niche, demonstrated a paradigm shift: ownership is no longer a static contract but a dynamic, verifiable record. In 2025, the International Confederation of Music Publishers (ICMP) acknowledged this evolution, endorsing hybrid models that combine traditional publishing with blockchain transparency. The economic implications were profound. Royalties, once a source of opaque negotiation, became data-driven transactions. Platforms now compete not just on catalog size, but on rights clarity and auditability. A 2026 study by Deloitte found that streaming services with “rights-verified” catalogs saw 18% higher artist retention and 12% lower royalty

disputes—driving a new market premium for transparency. Still, the transition exposed vulnerabilities. In Southeast Asia, where informal publishing networks thrive, digital registration systems struggled to integrate traditional songwriting collectives. In parts of the Middle East, religious music publishers resisted digital tracking, fearing cultural dilution. Novik’s legacy, then, is not one of total victory, but of forced evolution—pressuring the industry to reconcile legacy power with the imperative of equitable value distribution.

Expert Perspectives: From Legal Scholars to Frontline Creators

The academic and legal community responded to **Uprooted** with a spectrum of analysis, moving beyond sensationalism to rigorous critique. Copyright law professor Dr. Elena Petrova of the University of Amsterdam framed the case as a “watershed moment in digital rights jurisprudence,” arguing that Novik’s challenge “redefined the boundaries of authorship in networked environments.” She emphasized that the report’s true innovation lay not in exposing mistranslations or missing metadata, but in demonstrating how systemic opacity enables institutionalized inequity. At the policy level, former U.S. Copyright Office chief Carrie Madelain highlighted **Uprooted** as a catalyst for reform. “We treated copyright as a static relic,” she stated in a 2024 testimony, “but Novik showed it must be a living framework—responsive to technological change and grounded in fairness.” Her advocacy helped shape the 2025 U.S. Copyright Modernization Act, which mandated real-time metadata standards and expanded creators’ rights to audit algorithmic systems. Among practitioners, the response was more nuanced. Music attorney James Chen, who advises indie publishers in Southeast Asia, noted that while Western platforms now face pressure to improve, “true transformation requires local adaptation.” He pointed to Nigeria, where publishers still rely on oral contracts and informal licensing—systems that **Uprooted** exposed but cannot be replaced overnight. “Technology is a tool,” Chen argued, “but cultural and institutional trust is the foundation.” Frontline creators offered a more visceral perspective. Amina Diallo, a Senegalese Afrobeats songwriter, described her experience: “For years, I signed away my rights without understanding—just to get my music heard. Now, I see how that shaped the world: my work flows, but no one pays properly. Novik gave me back control.” Her testimony, included in **Uprooted**, became a rallying cry for the Global South’s creative class, many of whom still navigate a publishing landscape designed by
