Multinational corporations impose uniform slide templates across borders, risking cultural dissonance. A 2023 audit of Shell's global operations found that local teams in Indonesia and Mexico reported reduced engagement when forced to use templates ill-suited to regional communication styles. The lesson? Digital tools must enable, not erase, cultural specificity.
