Yet funding gaps and bureaucratic fragmentation persist, with FEMA assessments identifying over \$3 billion in required flood mitigation and structural reinforcement—funds frequently delayed by federal-state coordination challenges.

During its initial build, Moses's workforce drew tens of thousands of local laborers, many from immigrant and working-class backgrounds, though unionized crews and skilled trades were often limited by project prioritization and political patronage. Today, the New York State Department of Transportation (NYSDOT) contracts with regional construction firms—such as General Electric Transportation and Tutor Perini—for ongoing repairs, interchanges, and seismic retrofitting. The rise of smart infrastructure has introduced new industry layers: sensor networks for real-time traffic monitoring, adaptive signal systems, and pilot programs for electric vehicle (EV) charging along the corridor. Companies like Siemens and Aptiv are

testing connected vehicle technologies aimed at reducing congestion and improving safety. Yet these innovations remain patchy, constrained by legacy systems, funding volatility, and resistance to regulatory overhaul. The Interstate Construction Workers Union (IW 1-330) remains influential, advocating for job access and safety standards amid increasing automation and remote monitoring.

Engineering Legacy and Ethical Reckoning Transportation engineers and urban planners debate the LIE's future with urgent clarity. Dr. Maria Chen, a professor of civil engineering at Cornell University, argues that "we've treated the LIE as a static relic, but it must evolve into a dynamic system." She emphasizes the need for "adaptive capacity—floodable underpasses, solar-integrated barriers, and real-time rerouting algorithms"—to withstand sea-level rise and extreme weather.
