In Southeast Asia, countries like Vietnam and Indonesia have embraced Lippert-style modularity in disaster-resilient infrastructure. Flood-prone regions use slide-out electrical panels that allow rapid isolation and repair, minimizing blackout risks. Yet, these adoptions are not without tension. The U.S. Department of Defense, in partnership with ASEAN allies, has raised concerns about interoperability risks—different national variants of modular systems could hinder coalition operations or create vulnerabilities if foreign components are compromised.
