White's novel, a metaphysical odyssey across the desert, demanded more than narrative fidelity; it required a directorial vision attuned to silence, space, and the weight of silence between words—qualities Gow would refine over decades.

The Geopolitical Pulse: Theatre in an Era of Global Shift

Gow's career trajectory cannot be disentangled from the global context of the late 20th century. The 1980s and 90s witnessed seismic shifts: the end of the Cold War, the rise of neoliberalism, and the acceleration of cultural globalization. These forces reshaped funding models, artistic priorities, and audience expectations. By centering Indigenous voices and employing non-linear narrative structures, Gow challenged dominant historical narratives, aligning with broader global movements—like postcolonial re-evaluations in South Africa and Latin America—where theatre became a site of reckoning.

Economically, Gow's career mirrored the precariousness of the arts sector. He navigated a landscape where public subsidies were volatile, private philanthropy selective, and commercial viability often

incompatible with artistic integrity. His tenure as Artistic Director of the Melbourne Theatre Company (1998–2004) exemplified this tension. Under his leadership, the MTC expanded its repertoire to include international classics reimagined through local lenses—Stoppard’s **Arcadia** (2001), for instance, fused Victorian England with Australian presentism—while commissioning new works by emerging Australian writers. This dual strategy—honoring tradition while fostering innovation—was both a pragmatic survival tactic and a philosophical stance: that theatre must evolve to remain relevant.

Controversy and Institutional Power: The Gow Paradox

No account of Gow is complete without confronting the controversies that shadowed his influence. His unflinching engagement with taboo subjects—rape, colonial guilt, Indigenous dispossession—drew both acclaim and backlash. In 1996, his production of **The Matchmaker** by Sarah Ruhl, recontextualized through an Indigenous Australian lens, sparked debate in conservative media circles, accused of “politicizing the stage.” Yet, Gow dismissed such critiques as symptoms of institutional fear: “Art that unsettles is not dangerous—it reveals
