The resulting constitutional reforms—beginning with the 1970 State Reform and accelerating through the 1980s and 1993 Federal Constitution—transformed Belgium into a federal state structured along linguistic lines. Each of the three regions (Flanders, Wallonia, Brussels-Capital) was granted exclusive competences over language policy, education, and public administration. This institutional bifurcation turned language into a territorial sovereignty. Brussels’ multilingualism, though fraught, positions it as a global diplomatic nexus. The 1970 State Reform granted regions full control over language policy, education, and cultural affairs, effectively federalizing language administration. This devolution was not neutral; it formalized a spatial and institutional division that turned language into a tool of regional sovereignty. Crucially, the German-speaking community, carved out in 1963, was a pragmatic compromise—recognizing a minority without altering the dominant trilingual framework.
