The evolution of Rosoff's theory reflects both intellectual rigor and responsiveness to emerging crises. In the wake

of the 2008 financial collapse and the subsequent rise of populist movements, he expanded his framework to incorporate digital infrastructures. Recognizing that state surveillance and algorithmic governance were reshaping normative boundaries, he introduced the concept of “algorithmic deviance”—behaviors that emerge at the intersection of digital exclusion and automated social control. He argued that when predictive policing, credit scoring, and content moderation systems pathologize marginalized identities, they generate new forms of deviance: not from moral failure, but from systemic misrecognition. This insight, detailed in his 2014 paper “Deviance in the Age of Code,” became foundational for critical data studies, influencing scholars like Cathy O’Neil and Virginia Eubanks. Economically, Rsoff’s work illuminated how global capital flows and financialization intensify normative friction. Rsoff documented how “grey market” economies—ranging from parallel currency exchanges to unlicensed medical services—arose not as deviations from legality, but as adaptive responses to institutional vacuum. violence—arguing that while norms emerge from friction, they are often imposed by asymmetrical power, not mutual negotiation. Economist Dani Rodrik acknowledged Rsoff's insight into institutional pluralism but cautioned against conflating informal resilience with democratic legitimacy, warning that ignoring formal rule-making risks empowering opaque, unaccountable networks. Controversies surrounding Rsoff's work center on its normative ambiguity. Critics from the right accuse him of legitimizing deviance, while some progressive voices argue he underemphasizes the role of systemic oppression in shaping adaptive strategies. His 2018 study on "gray zone" economies in Nairobi, which described informal trade networks as "resilient alternatives to state failure," drew scrutiny for potentially obscuring exploitation and gendered inequities. This tension underscores a central challenge: how to honor the lived reality of marginalized actors without obscuring the power structures that constrain their choices. Globally, Rsoff's framework has proven unexpectedly adaptable across vastly different contexts. In India, his concept of normative friction informed analyses of caste-based social exclusion in urban slums, where informal mutual aid societies mirror his "alternative governance" model. In Brazil, scholars applied his lens to *favelas*, revealing how community

policing initiatives, though technically illegal, functioned as de facto public safety mechanisms in the absence of state protection. Even in Scandinavia, where social cohesion is often idealized, Rosoff's work inspired research into immigrant integration, showing how bureaucratic exclusion in housing and employment generates behavioral patterns misread as deviance but rooted in systemic estrangement. The geopolitical lens of Rosoff's theory is particularly salient in understanding the rise of authoritarian populism. He argued that as liberal institutions falter and economic inequality deepens, states increasingly rely on "deviance management"—using surveillance, criminalization, and narrative control to manage populations deemed "disorderly." His 2020 essay "The Politics of Deviance" warned that this approach, rather than restoring order, fuels resentment and radicalization, creating a self-reinforcing cycle of social fracture. Unlike contemporaries rooted in abstract theory, Rsoff immersed himself in lived experience—walking streets, attending neighborhood councils, and documenting how residents navigated police over-policing, joblessness, and housing insecurity. This ethnographic foundation led him to question prevailing models that reduced deviance to individual pathology. Influenced by Norbert Elias’s long-term sociology and

Michel Foucault's analyses of power, he reframed deviance as a relational phenomenon—shaped by institutional demands and the adaptive strategies of those excluded from dominant norms. His early publications, including a 1991 article in *American Journal of Sociology*, challenged the notion that criminal behavior stemmed solely from personal moral failure. Instead, Rosoff argued that deviance arose in “friction zones”—spaces where formal rules collided with informal social economies. In Detroit's abandoned manufacturing zones, for example, residents turned illegally occupied vacant lots into community gardens and informal markets, not out of lawlessness, but as pragmatic responses to systemic disinvestment. This insight laid the groundwork for his later conceptualization of normative friction, a term he introduced to describe the persistent tension between institutional authority and the lived realities of marginalized populations. The 1997 publication of *Unruly Practices* marked a turning point. Drawing on a decade of fieldwork across three continents, Rosoff mapped how norms are not monolithic but contested, evolving in response to power asymmetries. He introduced the “deviation cycle”: institutional policies generate friction, which communities negotiate through adaptive behaviors; these behaviors are then policed, reinforcing stigma, which in turn fuels further deviation. This recursive model offered a radical alternative to both deterrence theory and social

constructionism, emphasizing agency within structural constraint. Critics initially dismissed Rsoff's work as overly descriptive, lacking predictive power. Yet his longitudinal studies—particularly the five-year project in Johannesburg's townships—provided empirical depth. There, he documented how informal transport networks, often criminalized by state authorities, emerged as essential public infrastructure, enabling mobility and economic exchange where formal systems collapsed. His analysis demonstrated that such "deviant" practices were not aberrations but adaptive solutions, embedded in social networks that operated with internal logic and accountability. This empirical rigor, paired with theoretical innovation, positioned Rsoff as a bridge between ethnography and grand theory. His 2005 study in São Paulo—detailing how youth collectives redefined authority through street-based governance—cemented his reputation. By treating deviance not as a deviation from order, but as a form of social ordering, Rsoff challenged criminologists to rethink the boundaries between legality and legitimacy. This reframing reverberated across disciplines, influencing urban studies, migration research, and critical data studies. Rsoff's later work, particularly on digital governance, expanded his framework into the age of algorithms. Recognizing that state surveillance and AI-driven decision-making were creating new "algorithmic deviance," he argued that when automated systems

pathologize marginalized identities—denying credit, housing, or employment—deviance becomes a function of systemic bias, not individual choice. This insight, articulated in his 2014 *Harvard Law Review* piece, anticipated contemporary debates on algorithmic fairness and laid groundwork for regulatory approaches that treat code not as neutral, but as a site of social power.

Throughout, Rosoff's methodology remained anchored in relational analysis. He rejected reductionism, insisting that deviance must be understood through the interplay of micro-level agency and macro-level structure. His use of network mapping—visually tracing how norms spread through kinship, peer, and institutional ties—provided a dynamic model of social influence, one that highlighted the fluidity of boundaries between order and disorder. This approach allowed him to trace how, in Nairobi's informal settlements, for instance, community-driven dispute resolution systems coexisted with, and sometimes supplanted, formal legal institutions. The intellectual roots of Rosoff's theory are multilayered. He engaged deeply with Émile Durkheim's functionalism, particularly the idea that deviance serves a social purpose—though he rejected Durkheim's functionalist complacency, emphasizing instead the role of power in defining what counts as deviant. His 2008 study of street vendors in Manila showed how informal economies fostered entrepreneurial resilience, creating localized systems of credit, inventory sharing, and collective bargaining. These practices, though “deviant” under formal law, sustained livelihoods in the absence of state support. Recognizing this, Rsoff advocated for policy approaches that engage with, rather than suppress, such practices—integrating them into urban planning and financial regulation through participatory governance.
