Geopolitically, ARB's development coincided with rising calls for epistemic sovereignty—particularly in Africa and Latin America—where scholars and policymakers demanded accounting frameworks responsive to local development needs. The theory gained momentum through regional academic networks, including the African Accounting Association and the Latin American Institute of Accounting, which hosted symposia debating its applicability across diverse institutional ecosystems.

Today, as climate finance, ESG metrics, and digital currencies redefine global accountability, ARB's principles resonate with renewed urgency.
