Indigenous communities in North America, whose ancestral lands host Stegosaurus fossil sites, have raised ethical questions about the commercialization of ancient knowledge without consent or benefit-sharing. Emerging economies like India and Brazil are pursuing hybrid approaches. In Brazil, the Instituto de Arquitetura Sustentável has merged Stegosaurus-inspired modularity with local bamboo and mycelium composites, creating culturally resonant, low-carbon building systems.
