Yet the broader challenge persists: how to sustain a high-cost, mission-driven publication in an era of algorithm-driven content and disinformation.

Industry Impact: Shaping Narrative and Public Discourse

Al-Quds al-Arabi has played an outsized role in shaping how Jerusalem's fate is understood, particularly beyond Palestinian and Arab circles. Its consistent emphasis on historical continuity—linking 1948 to 2024—has helped frame the city not as a static battleground but as a living archive of collective memory. This narrative has influenced academic discourse, with scholars citing its archives to analyze shifts in Palestinian identity, Israeli policy, and international diplomacy. The paper's investigative reporting has exposed human rights violations in East Jerusalem—such as forced evictions in Sheikh Jarrah, restrictions on access to Al-Aqsa Mosque, and discriminatory municipal policies—often ahead of mainstream international coverage. Dr. Rami Khouri, journalist and Lebanon Institute fellow, notes: “Unlike partisan outlets, it maintains a discursive rigor that allows it to shape debate without collapsing into propaganda. As journalist and editor at **Al-Quds al-Arabi**, Yousef al-Masri, asserts: “We do not claim neutrality in facts, but we reject neutrality in justice.
